Have your say on the way Wales is funded

The Welsh Assembly Government has established an Independent Commission on Funding and Finance for Wales.

The Commission is reviewing the way in which resources are allocated to the Assembly Government and considering the case for change. The Commission has recently published its first report, which focused mainly on how Wales is currently funded by a block grant and made suggestions for changes to the block grant process. This report benefited from a range of helpful contributions received in response to a call for evidence, just like this one.

In the coming months, the Commission will be considering the case for devolution of tax and borrowing powers to Wales. The Commission would like to gather evidence from you relating to these subjects.
